貳、申請注意事項 Matters needing attention in application

招生依據：教育部「外國學生來臺就學辦法」及教育部臺教文(五)第字第 1150060128 號核定本校之「大仁科技大學外國學生招生規定」為基準。辦法如經修正，依教育部公告為準。

Basis for Admission: The admission of foreign students shall be based on the “Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan” issued by the Ministry of Education, and the “Tajen University Regulations for the Admission of Foreign Students” approved by the Ministry of Education under Taiwan educational document (5) 1150060128. If the regulations are amended, the latest announcement by the Ministry of Education shall prevail.

一、招生對象 Target of enrollment：

- (一) 具外國國籍且未曾具有中華民國國籍（註1）者，符合下列規定者，得依本規定申請入學：Applicants who hold foreign nationality and have never held Republic of China (ROC) nationality (Note 1), and who meet the following requirements, may apply for admission in accordance with these regulations.
1. 未曾以僑生身分在臺就學。The applicant has never studied in Taiwan as an overseas Chinese student.
 2. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。The applicant has not been assigned admission by the University Entrance Committee for Overseas Compatriot Students under the Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan for the same academic year of application.
- (二) 具外國國籍並符合下列規定，且最近連續居留海外6年以上，亦得依本規定申請入學：The applicant holds foreign nationality, meets the following requirements, and has continuously resided overseas for at least six consecutive years, and may also apply for admission in accordance with these regulations.
1. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。The applicant holds Republic of China (ROC) nationality at the time of application and shall have never registered household residence in Taiwan.
 2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿8年。The applicant previously held ROC nationality but no longer possesses it at the time of application shall have completed at least eight years from the date of approval of loss of ROC nationality by the Ministry of the Interior to the date of application.
 3. 前二款均應符合前項第一款及第二款規定。The applicants described in the preceding two items shall also comply with the provisions of Items 1 and 2 of the preceding paragraph.
- (三) 依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前二項規定之限制。Foreign nationals recommended to study in Taiwan by foreign governments, institutions, or schools under

education cooperation agreements, who have never held household registration in Taiwan, may, upon approval by the Ministry of Education, be exempted from the restrictions of the preceding two items.

- (四) 第二項所定 6 年，以擬入學當學期起始日期（2 月 1 日或 8 月 1 日）為終日計算之。

The six-year periods specified in Item 2 shall be calculated up to the start date of the semester for which admission is sought (February 1st or August 1st).

- (五) 第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間未逾 120 日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾 120 日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：For the purposes of Item 2, “overseas” refers to countries or regions other than Mainland China, Hong Kong, and Macau; “continuous residence” means that the foreign student has not stayed in Taiwan for more than 120 days in any calendar year. For periods in which the start or end year does not constitute a full calendar year, continuous overseas residence shall be recognized if the stay in Taiwan during that year does not exceed 120 days. However, if any of the following circumstances are met and supported by relevant documentation, this restriction shall not apply, and the time spent in Taiwan shall not be counted toward the calculation of overseas residence:

1. 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。The applicant has attended a technical training class organized by the Overseas Community Affairs Council or a technical training program recognized by the Ministry of Education.
2. 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿 2 年。The applicant has studied at a Mandarin Chinese Language Center of a higher education institution approved by the Ministry of Education to admit foreign students, for a total period of less than two years.
3. 交換學生，其交換期間合計未滿 2 年。The applicant has participated as an exchange student for a total period of less than two years.
4. 經中央目的事業主管機關許可來臺實習，實習期間合計未滿 2 年。The applicant has been permitted by the competent central authority to undertake an internship in Taiwan, with a total internship period of less than two years.

- (六) 具外國國籍並兼具中華民國國籍，且於教育部外國學生來臺就學辦法中華民國 100 年 2 月 1 日修正施行前已提出申請喪失中華民國國籍者，得依原招生規定申請入學，不受第二項規定之限制。The applicant holds foreign nationality and also possesses Republic of China (ROC) nationality, and has submitted an application for the loss of ROC nationality before the amendment and enforcement of the Regulations Regarding Study and Counseling Assistance for Foreign Students in Taiwan on February 1st, 2011. Such applicants may apply

for admission in accordance with the original enrollment regulations and are not subject to the provisions of Item 2.

- (七) 具有國籍法第二條規定情形者，為本規定所定具有中華民國國籍。Persons who fall under the circumstances specified in Article 2 of the Nationality Act are considered to possess Republic of China (ROC) nationality under these Regulations.
- (八) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿6年以上（註2、3）者，得依本規定申請入學。Applicants who hold foreign nationality, also possess permanent residency in Hong Kong or Macau, have never held household registration in Taiwan, and have continuously resided in Hong Kong, Macau, or overseas for at least six consecutive years at the time of application (Note 2,3) may apply for admission in accordance with these Regulations.
- (九) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外6年以上（註2、3）者，得依本規定申請入學。Applicants who were formerly nationals of Mainland China, hold foreign nationality, and have never held household registration in Taiwan, and who have continuously resided overseas for at least six consecutive years at the time of application (Note 2,3) may apply for admission in accordance with these Regulations.
- (十) 外國學生依前二條規定申請來臺就學，以一次為限；如繼續在本校就讀下一學程，其入學方式應與我國內一般學生相同。Foreign students may apply to study in Taiwan in accordance with the preceding two Articles only once; if they continue to enroll in the next program at the same institution, their admission procedure shall be the same as that for domestic students.
- (十一) 外國學生有下列情形之一者，其於前項申請後，復申請繼續在臺就學，或再次申請來臺就學，不受前項規定之限制：Foreign students who meet any of the following conditions may, after the application referred to in the preceding paragraph, reapply to continue studying in Taiwan or reapply for admission to study in Taiwan, without being subject to the limitation specified in the preceding paragraph.
1. 於完成申請學校學程後，申請碩士班以上學程，依本校規定辦理。After completing the program at the applied institution, applicants may apply for a master's program or higher, and the admission shall be handled in accordance with the regulations of the institution.
 2. 外國學生申請來臺就讀學士班以下學程，在國內停留未滿1年，因故退學或喪失學籍者，得重新申請來臺就學，並以一次為限。Foreign students applying to study in Taiwan in a program below the bachelor's level, who have stayed in Taiwan for less than one year and have withdrawn or lost their student status for any reason, may reapply to study in Taiwan, and such reapplication is limited to once.
 3. 符合第二條第一項規定之外國學生，申請入學大學醫學牙醫或中醫學系以外之學士

班學程，並以一次為限。Foreign students who meet the requirements of Article 2, Paragraph 1 may apply for admission to undergraduate programs other than medical, dental, or traditional Chinese medicine departments of universities, limited to one application per student.

- (十二) 外國學生經入學學校以操行不及格或學業考核未達規定，違反法令或校規情節嚴重致遭退學或喪失學籍者，不得再依前二項規定申請入學。Foreign students who have been expelled or have lost their student status due to failing conduct evaluations or academic assessments, or for serious violations of laws or school regulations at the enrolled institution, shall not be allowed to apply for admission again in accordance with the preceding two provisions.
- (十三) 外國學生申請入學本校學歷須符合教育部採認之高中、大學或獨立學院畢業者(請參考教育部國際及兩岸教育司 <https://depart.moe.edu.tw/ed2500/News.aspx?n=E8380E03A0E16960&sms=D2E10027BB4EC183>) Foreign students applying for admission to this institution must hold a high school, university, or independent college diploma recognized by the Ministry of Education (please refer to the Department of International and Cross-Strait Education, Ministry of Education <https://depart.moe.edu.tw/ed2500/News.aspx?n=E8380E03A0E16960&sms=D2E10027BB4EC183>).
- (十四) 外國學生具國外高中畢業資格者或具有與我國學制相當之同等學力資格者，得申請入學本校學士班；具學士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校碩士班。Foreign students who hold a foreign high school diploma or possess equivalent academic qualifications comparable to Taiwan's education system may apply for admission to the bachelor's program of the institution; those who hold a bachelor's degree or possess equivalent academic qualifications comparable to Taiwan's education system may apply for admission to the master's program of the institution.
- (十五) 畢業年級相當於臺灣高級中等學校二年級或香港、澳門地區同級同類學校畢業生得申請本校學士班，並應在規定之修業期限內增加其應修畢業學分數 12 學分。Graduates whose grade level is equivalent to the second year of senior high school in Taiwan, or graduates from equivalent schools of the same level in Hong Kong or Macau, may apply for the bachelor's program of this institution, and must complete an additional 12 credits on top of the required graduation credits within the prescribed period of study.
- (十六) 115 學年度申請至本校春、秋季班就讀之外國學生，所備文件及相關規定應以中華民國教育部網站公布之最新「外國學生來臺就學辦法」之規定為準，請申請者隨時查閱教育部網站(<https://www.edu.tw/Default.aspx>) 及本校網站(<https://www.tajen.edu.tw/>)。For the 115th academic year, foreign students applying for the spring or fall semester at this institution must prepare documents and follow the relevant regulations in accordance with the

latest “Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan” published on the Ministry of Education, R.O.C. website. Applicants are advised to consult the Ministry of Education website (<https://english.moe.gov.tw/mp-1.html>) and the institution’s website (<https://www.tajen.edu.tw/index.php?Lang=en>) at any time.

(十七) 本校招收已在臺就讀外國學生轉學符合下列報考本校學士班轉學資格者，得申請轉入本校學士班相銜接之年級就讀，但經入學學校以操行不及格或因刑事案件經判刑確定致遭退學者，不得轉學進入本校就讀。Foreign students already studying in Taiwan who meet the following transfer qualifications for applying to our undergraduate programs may apply to transfer to the corresponding year of our undergraduate program. However, students who have been expelled from their current school due to poor conduct or criminal convictions are not eligible to transfer to our school.

1. 修業滿二個學期者，可報考各學系二年級。Students who have completed two semesters of study are eligible to apply for the second year of any department.
2. 修業滿四個學期者，可報考各學系二年級或三年級。Students who have completed four semesters of study are eligible to apply for the second or third year of study in any department.

(十八) 本校之外國學生招生事務，除宣傳、推廣及協助學生辦理來臺必要程序外，不得委由校外機構、法人、團體或者個人辦理；並應適時確認是否向外國學生收取不合理之費用、成立借貸關係或其他違反相關法令之情形，必要時得向申請之外國學生查核。
The university shall not delegate the recruitment of foreign students to any external institutions, legal entities, groups or individuals except for publicity, promotion and assistance to students in completing the necessary procedures for coming to Taiwan; and shall promptly confirm whether unreasonable fees are charged to foreign students, whether a loan relationship is established or other situations violate relevant laws and regulations, and may verify with the foreign students who have applied when necessary.

註 1：中華民國國籍法第二條 Note 1: Article 2 of the Nationality Act of the Republic of China (R.O.C.)

- 一、出生時父或母為中華民國國民。A person whose father or mother is a national of the Republic of China (R.O.C.) at the time of birth.
- 二、出生於父或母死亡後，其父或母死亡時為中華民國國民。A person born after the death of the father or mother, if the deceased parent was a national of the R.O.C. at the time of death.
- 三、出生於中華民國領域內，父母均無可考，或均無國籍者。A person born within the territory of the R.O.C. whose parents are both unidentifiable or stateless.
- 四、歸化者。A naturalized person.

前項第一款及第二款之規定，於本法中華民國 89 年 2 月 9 日修正施行時未滿 20 歲之人，亦適用之。The provisions of the preceding paragraph, items 1 and 2, shall also apply to persons who were under 20 years of age at the time this Act was amended and implemented on February 9th, 2000 (Republic of China Year 89).

註 2：前項所稱連續居留，指每曆年在國內停留期間，合計未逾 120 日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入前項連續居留期間計算。Note 2: The term “continuous residence” referred to in the preceding paragraph means that the total period of stay within Taiwan in any calendar year does not exceed 120 days. However, this limitation does not apply to individuals who meet any of the conditions listed in items 1 through 4 of Paragraph 5 of the preceding article and possess the relevant supporting documents; the period of stay within Taiwan for such individuals shall not be counted toward the calculation of continuous residence.

註 3：所定 6 年，以擬入學當學期起始日期（2 月 1 日或 8 月 1 日）為終日計算之。Note 3: The six-year period shall be calculated up to the starting date of the intended semester of enrollment (February 1st or August 1st).

三、申請資料 Application materials

(一) 應繳文件 Required documents

- 1.線上填寫入學申請表(檢附兩寸半身照片)。申請資料除照片應以 JPG 檔案上傳外，其他則以 PDF 檔案上傳，請依各項文件欄位逐一上傳，每一文件項目僅可上傳單一檔案。申請生若單一項目有多個電子檔，請自行合併成一個檔案後再上傳，並以 2MB 為限，逾時將不予受理，所有申請文件一概不退還，請自行保留備份。
Complete the online admission application form (attach a two-inch half-length photo). All documents for applications, excluding images, should be uploaded as JPG files. Others are submitted as PDF files; please upload each file individually in accordance with the appropriate section; each file item can only upload one file. The maximum file size for upload is 2 MB; if applicants have many electronic files for a single project, please combine them into a single file before uploading. Overdue submissions will not be accepted, and all application materials will not be returned.

credentials from Taiwanese business schools and international schools are equivalent to those from comparable institutions in my home country.

However, academic qualifications from foreign schools with campuses or branch campuses in mainland China must be notarized by a notary public office in mainland China and verified by a non-governmental organization commissioned by an institution established or designated by the Executive Yuan.

(4) 畢(結)業年級相當於臺灣高級中等學校二年級或香港、澳門地區同級同類學校畢業生得申請本校學士班，並得依本校學則規定於畢業前補修十二學分以上(含)方得符合畢業資格。補修之學分不列入畢業學分。Graduation (complete) (completion), The school's bachelor's program is open to applicants with grades equivalent to the second grade of senior high schools in Taiwan or graduates of institutions of a comparable caliber in Hong Kong and Macau. Applicants may complete more than 12 credits (including) before graduation in accordance with the requirements of the school. must be qualified to graduate. Supplemental course credits are not counted toward graduation.

3.護照影本或國籍證明文件影本一份。A copy of your passport or a copy of your nationality certificate.

4.中文或英文自傳、讀書計畫乙份。One copy of a study schedule and autobiography in either Chinese or English.
