## 貳、申請注意事項 Matters needing attention in application

招生依據：教育部「外國學生來臺就學辦法」及教育部臺教文(五)第字第 1140105896 號核定本校之「大仁科技大學外國學生招生規定」為基準。辦法如經修正，依教育部公告為準。  
Basis for Admission: The admission of foreign students shall be based on the “Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan” issued by the Ministry of Education, and the “Tajen University Regulations for the Admission of Foreign Students” approved by the Ministry of Education under Taiwan educational document (5) 1140105896. If the regulations are amended, the latest announcement by the Ministry of Education shall prevail.

### 一、招生對象 Target of enrollment :

- (一) 具外國國籍且未曾具有中華民國國籍（註 1）者，符合下列規定者，得依本規定申請入學：Applicants who hold foreign nationality and have never held Republic of China (ROC) nationality (Note 1), and who meet the following requirements, may apply for admission in accordance with these regulations.
1. 未曾以僑生身分在臺就學。The applicant has never studied in Taiwan as an overseas Chinese student.
  2. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。The applicant has not been assigned admission by the University Entrance Committee for Overseas Compatriot Students under the Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan for the same academic year of application.
- (二) 具外國國籍並符合下列規定，且最近連續居留海外 6 年以上，亦得依本規定申請入學：The applicant holds foreign nationality, meets the following requirements, and has continuously resided overseas for at least six consecutive years, and may also apply for admission in accordance with these regulations.
1. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。The applicant holds Republic of China (ROC) nationality at the time of application and shall have never registered household residence in Taiwan.
  2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿 8 年。The applicant previously held ROC nationality but no longer possesses it at the time of application shall have completed at least eight years from the date of approval of loss of ROC nationality by the Ministry of the Interior to the date of application.
  3. 前二款均應符合前項第一款及第二款規定。The applicants described in the preceding two items shall also comply with the provisions of Items 1 and 2 of the preceding paragraph.
  4. 依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前二項規定之限制。Foreign nationals recommended to study in Taiwan by foreign governments, institutions, or schools under

education cooperation agreements, who have never held household registration in Taiwan, may, upon approval by the Ministry of Education, be exempted from the restrictions of the preceding two items.

5. 第二項所定 6 年、8 年，以擬入學當學期起始日期（2 月 1 日或 8 月 1 日）為終日計算之。The six-year and eight-year periods specified in Item 2 shall be calculated up to the start date of the semester for which admission is sought (February 1<sup>st</sup> or August 1<sup>st</sup>).
6. 第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間未逾 120 日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾 120 日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：For the purposes of Item 2, “overseas” refers to countries or regions other than Mainland China, Hong Kong, and Macau; “continuous residence” means that the foreign student has not stayed in Taiwan for more than 120 days in any calendar year. For periods in which the start or end year does not constitute a full calendar year, continuous overseas residence shall be recognized if the stay in Taiwan during that year does not exceed 120 days. However, if any of the following circumstances are met and supported by relevant documentation, this restriction shall not apply, and the time spent in Taiwan shall not be counted toward the calculation of overseas residence:
  - (1) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。The applicant has attended a technical training class organized by the Overseas Community Affairs Council or a technical training program recognized by the Ministry of Education.
  - (2) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿 2 年。The applicant has studied at a Mandarin Chinese Language Center of a higher education institution approved by the Ministry of Education to admit foreign students, for a total period of less than two years.
  - (3) 交換學生，其交換期間合計未滿 2 年。The applicant has participated as an exchange student for a total period of less than two years.
  - (4) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿 2 年。The applicant has been permitted by the competent central authority to undertake an internship in Taiwan, with a total internship period of less than two years.
7. 具外國國籍並兼具中華民國國籍，且於教育部外國學生來臺就學辦法中華民國 100 年 2 月 1 日修正施行前已提出申請喪失中華民國國籍者，得依原招生規定申請入學，不受第二項規定之限制。The applicant holds foreign nationality and also possesses Republic of China (ROC) nationality, and has submitted an application for the loss of ROC nationality before the amendment and enforcement of the Regulations Regarding Study

and Counseling Assistance for Foreign Students in Taiwan on February 1<sup>st</sup>, 2011. Such applicants may apply for admission in accordance with the original enrollment regulations and are not subject to the provisions of Item 2.

8. 具有國籍法第二條規定情形者，為本辦法所定具有中華民國國籍。Persons who fall under the circumstances specified in Article 2 of the Nationality Act are considered to possess Republic of China (ROC) nationality under these Regulations.

(三) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿6年以上（註2）者，得依本規定申請入學。所定6年，以擬入學當學期起始日期（2月1日或8月1日）為終日計算之。Applicants who hold foreign nationality, also possess permanent residency in Hong Kong or Macau, have never held household registration in Taiwan, and have continuously resided in Hong Kong, Macau, or overseas for at least six consecutive years at the time of application (Note 2) may apply for admission in accordance with these Regulations. The six-year period shall be calculated up to the starting date of the intended semester of enrollment (February 1<sup>st</sup> or August 1<sup>st</sup>).

(四) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外6年以上（註3）者，得依本規定申請入學。所定6年，以擬入學當學期起始日期（2月1日或8月1日）為終日計算之。Applicants who were formerly nationals of Mainland China, hold foreign nationality, and have never held household registration in Taiwan, and who have continuously resided overseas for at least six consecutive years at the time of application (Note 3) may apply for admission in accordance with these Regulations. The six-year period shall be calculated up to the starting date of the intended semester of enrollment (February 1<sup>st</sup> or August 1<sup>st</sup>).

(五) 外國學生依前二條規定申請來臺就學，以一次為限；如繼續在本校就讀下一學程，其入學方式應與我國內一般學生相同。外國學生有下列情形之一者，其於前項申請後，復申請繼續在臺就學，或再次申請來臺就學，不受前項規定之限制：Foreign students may apply to study in Taiwan in accordance with the preceding two Articles only once; if they continue to enroll in the next program at the same institution, their admission procedure shall be the same as that for domestic students. Foreign students who meet any of the following conditions may, after the application referred to in the preceding paragraph, reapply to continue studying in Taiwan or reapply for admission to study in Taiwan, without being subject to the limitation specified in the preceding paragraph.

1. 於完成申請學校學程後，申請碩士班以上學程，依本校規定辦理。After completing the program at the applied institution, applicants may apply for a master's program or higher, and the admission shall be handled in accordance with the regulations of the institution.

2. 外國學生申請來臺就讀學士班以下學程，在國內停留未滿1年，因故退學或喪失學

籍者，得重新申請來臺就學，並以一次為限。Foreign students applying to study in Taiwan in a program below the bachelor's level, who have stayed in Taiwan for less than one year and have withdrawn or lost their student status for any reason, may reapply to study in Taiwan, and such reapplication is limited to once.

3.符合第二條第一項規定之外國學生，申請就讀副學士以下學程。Foreign students who meet the provisions of Article 2, Paragraph 1, may apply to enroll in programs below the associate degree level.

4.外國學生經入學學校以操行不及格或學業考核未達規定，違反法令或校規情節嚴重致遭退學或喪失學籍者，不得再依前二項規定申請入學。Foreign students who have been expelled or have lost their student status due to failing conduct evaluations or academic assessments, or for serious violations of laws or school regulations at the enrolled institution, shall not be allowed to apply for admission again in accordance with the preceding two provisions.

(六) 外國學生申請入學本校學歷須符合教育部採認之高中、大學或獨立學院畢業者(請參考教育部國際及兩岸教育司

<https://depart.moe.edu.tw/ed2500/News.aspx?n=E8380E03A0E16960&sms=D2E10027BB4EC183>)Foreign students applying for admission to this institution must hold a high school, university, or independent college diploma recognized by the Ministry of Education (please refer to the Department of International and Cross-Strait Education, Ministry of Education<https://depart.moe.edu.tw/ed2500/News.aspx?n=E8380E03A0E16960&sms=D2E10027BB4EC183>).

(七) 外國學生具國外高中畢業資格者或具有與我國學制相當之同等學力資格者，得申請入學本校學士班；具學士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校碩士班。Foreign students who hold a foreign high school diploma or possess equivalent academic qualifications comparable to Taiwan's education system may apply for admission to the bachelor's program of the institution; those who hold a bachelor's degree or possess equivalent academic qualifications comparable to Taiwan's education system may apply for admission to the master's program of the institution.

(八) 畢業年級相當於臺灣高級中等學校二年級或香港、澳門地區同級同類學校畢業生得申請本校學士班，並應在規定之修業期限內增加其應修畢業學分數 12 學分。Graduates whose grade level is equivalent to the second year of senior high school in Taiwan, or graduates from equivalent schools of the same level in Hong Kong or Macau, may apply for the bachelor's program of this institution, and must complete an additional 12 credits on top of the required graduation credits within the prescribed period of study.

(九) 115 學年度申請至本校春、秋季班就讀之外國學生，所備文件及相關規定應以中華民國教育部網站公布之最新「外國學生來臺就學辦法」之規定為準，請申請者隨時查閱

教育部網站(<https://www.edu.tw/Default.aspx>)及本校網站(<https://www.tajen.edu.tw/>)。

For the 115th academic year, foreign students applying for the spring or fall semester at this institution must prepare documents and follow the relevant regulations in accordance with the latest “Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan” published on the Ministry of Education, R.O.C. website. Applicants are advised to consult the Ministry of Education website (<https://english.moe.gov.tw/mp-1.html>) and the institution’s website (<https://www.tajen.edu.tw/index.php?Lang=en>) at any time.

(十) 外國學生於我國各大學肄業，符合下列報考本校學士班轉學資格者，得申請轉入本校學士班相銜接之年級就讀。Foreign students who are enrolled in one of the many universities in my nation and who match the requirements listed below can apply to transfer to the grade that is associated with the undergraduate program at our institution.

1. 修業滿二個學期者，可報考各學系二年級。Candidates for each department's second year may apply after completing two semesters of study.
2. 修業滿四個學期者，可報考各學系二年級或三年級。Candidates for each department's second or third year may submit an application after completing four semesters of study.
3. 外國學生經錄取入學後實際抵免學分數由各學系及通識教育中心分別審核確定，若因學分抵免不足，須延長修業期限，概依規定辦理，不得異議，有關學分抵免問題，可先與各系助教或註冊課務組聯繫。The general education center and each department decide the precise amount of credits that international students will actually receive after being admitted. The study term must be prolonged if the credit hours are insufficient, and it will be handled in line with the rules. No opposition is accepted. If you have any questions regarding credit hours, you should first speak with the department's teaching assistants or registration staff.

(十一) 本校之外國學生招生事務，教育部明訂除宣傳推廣及協助學生辦理來台相關畢業程序以外不得委由校外機構，法人，團體或者個人辦理。並需要確定是否向申請入學之外國學生收取不合理之費用或成立借貸關係及違反相關法令。於面試時必要得像申請之外國學生進行查核。Regarding the admission affairs of foreign students at this institution, the Ministry of Education explicitly stipulates that, except for promotion and assisting students with relevant procedures for studying in Taiwan, such matters shall not be handled by external agencies, legal entities, organizations, or individuals. It is also necessary to verify whether unreasonable fees are charged to foreign applicants or if any lending arrangements are established in violation of relevant laws. During interviews, it is essential to conduct verification checks on the applying foreign students.

註 1：中華民國國籍法第二條 Note 1: Article 2 of the Nationality Act of the Republic of China (R.O.C.)

一、出生時父或母為中華民國國民。A person whose father or mother is a national of the Republic of China (R.O.C.) at the time of birth.

二、出生於父或母死亡後，其父或母死亡時為中華民國國民。A person born after the death of the father or mother, if the deceased parent was a national of the R.O.C. at the time of death.

三、出生於中華民國領域內，父母均無可考，或均無國籍者。A person born within the territory of the R.O.C. whose parents are both unidentifiable or stateless.

四、歸化者。A naturalized person.

前項第一款及第二款之規定，於本法中華民國 89 年 2 月 9 日修正施行時未滿 20 歲之人，亦適用之。The provisions of the preceding paragraph, items 1 and 2, shall also apply to persons who were under 20 years of age at the time this Act was amended and implemented on February 9<sup>th</sup>, 2000 (Republic of China Year 89).

註 2：前項所稱連續居留，指每曆年在國內停留期間，合計未逾 120 日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入前項連續居留期間計算。Note 2: The term “continuous residence” referred to in the preceding paragraph means that the total period of stay within Taiwan in any calendar year does not exceed 120 days. However, this limitation does not apply to individuals who meet any of the conditions listed in items 1 through 4 of Paragraph 5 of the preceding article and possess the relevant supporting documents; the period of stay within Taiwan for such individuals shall not be counted toward the calculation of continuous residence.

### 三、申請資料 Application materials

#### (一) 應繳文件 Required documents

Complete the online admission application form (attach a two-inch half-length photo). All documents for applications, excluding images, should be uploaded as JPG files. Others are submitted as PDF files; please upload each file individually in accordance with the appropriate section; each file item can only upload one file. The maximum file size for upload is 2 MB; if applicants have many electronic files for a single project, please combine them into a single file before uploading. Overdue submissions will not be accepted, and all application materials will not be returned.

The University's Regulations for the Recognition of Foreign Degrees must be followed when dealing with degrees from foreign countries other than those mentioned in the first two sections. However, the academic credentials of foreign schools with campuses or branches in the mainland area must be attested by a notary office there and confirmed by a body established or designated by the Executive Yuan or a non-governmental organization to which the Executive Yuan has delegated that authority.

Applicants may complete more than 12 credits (including) before graduation in accordance with the requirements of the school. must be qualified to graduate. Supplemental course credits are not counted toward graduation.

3. 中文或英文自傳、讀書計畫乙份。One copy of a study schedule and autobiography in

either Chinese or English.

4.最近三個月經由金融機構提出中文或英文存款證明新臺幣十五萬之財力證明（美金 5,000 元）。To demonstrate financial resources of NT\$150,000 (US\$5,000) in the previous three months, a financial institution must present a Chinese or English deposit certificate.

Recipients of full scholarships may use the scholarship certificate as proof of financial capacity (scholarship application forms are not accepted). Those who have already received a scholarship certificate from Taiwan must still provide a bank deposit certificate of at least 30,000 New Taiwan Dollars (or 1,000 US Dollars).

6.語文能力相關證明文件 Documents related to language proficiency

\*本校要求進入中文授課為主的學生應有基本華語聽說讀寫能力，因此外國學生於申請入學時得檢附已具基本聽說讀寫語言能力之相關證明，以作為入學資格審查有利之依據。建議語言能力證明如下 Foreign students must provide their own documentation when applying for admission because the school requires that students who are primarily taught in Chinese have basic Chinese listening, speaking, reading, and writing skills, and students who are primarily taught in English have basic English listening, speaking, reading, and writing skills. Relevant certifications of fundamental language proficiency in speaking, listening, reading, and writing are utilized as a good foundation for the admission qualifying exam. It is advised to show your language ability in the manners below :

B.中文為母語者或畢業於中文授課之學校並具證明者(例如：馬來西亞華文獨立中學畢業證書)或大學主修中文並具證明者。Those who can provide documentation of being a native speaker of Chinese, having completed a Chinese-medium education (for instance, a Malaysian Chinese Independent Secondary School Graduation Certificate), or having majored in Chinese.

(2) 申請英文學程者，其英語文能力測驗應達 CEFR B1（含）級以上。For applicants to English-taught programs, their English proficiency test scores should meet or exceed CEFR level B1.

7.各系所規定應繳交文件。It is necessary to submit the paperwork that each agency

requires.

- (1) 上述文件為初審必要文件，須齊全且合格後方送至系所做最後審查。The aforementioned papers must be complete and qualified before being given to the department for final inspection since they are required for the preliminary examination.
- (2) 申請科系所將以資料審查及面試進行申請入學審核。請務必提供口面試聯繫方式，以供聯繫。The applicant department will conduct an interview and examine the application for admission. Please be sure to provide the interviewer's contact information.
- (3) 注意事項：不符合報考資格或所繳證件有偽造、假借、塗改等情事，在錄取後未註冊前發覺者，應取消錄取資格；註冊入學後發覺者即開除學籍，不發給任何學籍證明。如在畢業後始發覺者，除勒令繳銷其畢業證書外，並公告取消其畢業資格。Precautions: Those who do not meet the requirements for the examination or who have forged, falsely borrowed, altered, etc., will have their admission qualifications revoked; those who are discovered after registration will be expelled from school and will not be given any documentation of their status as a student. If it is uncovered after graduation, in addition to being told to have their diplomas revoked, they will also have their graduation credentials canceled.
- (4) 外國學生已在臺完成學士以上學位，繼續申請入學碩士學制者，得檢具我國各大學校院畢業證書及歷年成績證明文件，不受外國學生來台就學辦法第七條第一項第二款規定限制。Foreign students who have already completed a bachelor's degree or higher in Taiwan and wish to continue their studies by applying for a master's program may submit graduation certificates and transcripts from universities in Taiwan. They are not subject to the restrictions outlined in Article 7, Paragraph 1, Subparagraph 2 of the Regulations Regarding International Students Undertaking Studies in Taiwan.
- (5) 本校審核外國學生之入學申請時，對外國學生來臺就學辦法第十八條第一項第二款未經我國駐外使領館、代表處、辦事處或其他經外交部授權機構、行政院設立或指定之機構或委託之民間團體驗證之文件認定有疑義時，得要求經驗證；其業經驗證者，得請求協助查證。When reviewing international students' admission applications, if there are doubts regarding documents that have not been authenticated by an ROC embassy, consulate, representative office, or other authorized institution designated or entrusted by the Ministry of Foreign Affairs or a private organization commissioned by the Executive Yuan, as outlined in Article 18, Paragraph 1, Subparagraph 2 of the Regulations Regarding International Students Undertaking Studies in Taiwan, the school may request authentication. If the

documents have already been authenticated, assistance in verifying them may be requested.

(二) 其他附件 other attachments

1. 外國學生註冊時，新生應檢附已於國外投保自入境當日起至少六個月效期之醫療及傷害保險，在校生應檢附我國全民健康保險等相關保險證明文件。國外之保險證明，應經駐外館處驗證。When international students register, new students must provide proof of having purchased medical and accident insurance abroad, with a validity of at least six months from the date of entry. Current students must provide proof of insurance, such as Taiwan's National Health Insurance or other relevant insurance documents. Insurance certificates issued abroad must be verified by ROC embassies or representative offices.

**四、申請注意事項 Application-related notes**

- (一) 外國學生經核准入學後悉依有關法令規定辦理。After receiving enrollment approval, overseas students must be treated in compliance with all applicable laws and regulations.
- (二) 申請人不曾以僑生身份在中華民國就讀。The applicant is an overseas Chinese student who has never attended school in the Republic of China.
- (三) 依教育部規定，外國學生經入學學校以操行、學業成績不及格或因犯刑事案件確定致遭退學者，不得再依「外國學生來臺就學辦法」向本校申請入學。若違反此規定並經查證屬實者，撤銷其入學資格。According to Ministry of Education regulations, foreign students who have been expelled from a school due to misconduct, poor academic performance, or a confirmed criminal conviction are not allowed to apply for admission to the university under the "Regulations Regarding International Students Undertaking Studies in Taiwan." If any violation of this rule is verified, their admission will be revoked.
- (四) 已報名或錄取之學生，如經發現申請資格不符規定或所繳交之證件有變造、偽造、假借、冒用等不實情事者，未入學者即取消錄取資格；已入學者開除學籍，亦不發給任何學歷證明；如將來在本校畢業後始發現者，除勒令繳銷其學位證書外，並公告取消其畢業資格。If a student who has applied or been admitted is found to have violated the application qualifications or submitted forged, altered, borrowed, or fraudulent documents, their admission will be revoked if they have not yet enrolled. If they have already enrolled, they will be expelled, and no academic certificate will be issued. If such a violation is discovered after graduation, the university will demand the return of their diploma and publicly cancel their graduation qualifications.
- (五) 所有申請之文件概不退還，請自行保留備份。All submitted application documents will not be returned. Please keep copies for your own records.
- (六) 外國學生申請來臺就學，以一次為限。其繼續在臺就學者，其入學方式應與我國內一般學生相同。但下列情形，不在此限：Foreign students are allowed to apply for studying

in Taiwan only once. Those who wish to continue their studies in Taiwan must follow the same admission procedures as local students. However, the following situations are exceptions to this rule :

1.於完成申請就學學校學程後，申請碩士班以上學程，得逕依本招生規定辦理。

Applicants who apply for a course of study beyond a master's degree may directly pursue the admission requirements after completing the school's application process.

2.外國學生申請來台就讀學士班以下學程，在國內停留未滿一年，因故退學或喪失學籍，得重新申請來臺就學，並以一次為限。Foreign students who seek to study for a bachelor's degree in Taiwan, stay in China for less than a year, discontinue their studies, or lose their student status for whatever reason are only permitted to reapply once to study in Taiwan.

(七) 其他相關規定 Other pertinent laws :

1.開課與抵免學分問題依現行學校規定與學則辦理。The matter of beginning classes and credit hours will be addressed in accordance with the most recent academic guidelines and school policies.

After completing registration and registration procedures, freshmen can only enroll in school after submitting these documents.
